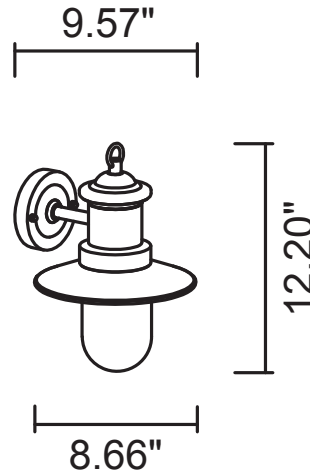

- Install fixture to a UL-listed weatherproof junction box suitable for outdoor use.
- Ensure all wiring connections are made inside a weatherproof electrical box.
- Use only listed outdoor-rated junction boxes and fittings.

2: Sealing cable entries for wet locations:

- Seal all openings and conduit entries with approved watertight fittings or silicone sealant to maintain Wet Location rating.
- Apply weatherproof gaskets and tighten all screws to prevent water ingress.
- Ensure all cable entries are properly sealed to comply with Wet Location requirements.
